ADULT SERVICES UPDATE

COMPREHENSIVE RE-ENTRY, CO-RESPONSE & TIDA DIVERSION

- Lisa Grossinger is our CRE social worker. She works with the inmates on mental health coordination, treatment coordination, and release planning.
 Services that are offered in the jail include weekly Mental Health Peer Support and therapy dog. Lisa has been facilitating Parenting Inside Out (PIO) classes and recently took the Circle of Security Training.
- Amy Brill is our Co-Response social worker and Christine Lorenzten is our TIDA Diversion Social Worker. Amy works closely with the Sheriff's Office and the Long Prairie and Staples Police Departments. She has worked with 101 people so far this year. Christine works closely with the County Attorney's Office with diverting those with mental health and substance use away from the criminal justice system. There are 2 ongoing diversion at this time. Since she started in January, Christine has taken on our commitments and currently has 13 on commitment.

- Currently working on increasing our presence in the community with doing 2 mental health events. Another goal is to increase the number of people with lived experience as we need 51% consumer participation.
