

Burnhamville Township Annual Meeting

March 8, 2016

The annual meeting of the residents of Burnhamville Township was held at the Burtrum Community Center on Tuesday, March 8, 2016. The meeting was called to order at 8:23 by the clerk Shirley Hulinsky. The Pledge of Allegiance was recited. Don Brown made a motion to appoint Gary Allen as moderator. Gary Allen made a motion to appoint Don Brown as moderator. Gary Braun seconded the motion to appoint Don Brown as moderator and upon vote motion passed.

The minutes of the annual meeting held on March 10, 2015 were read by the clerk Shirley Hulinsky. Motion was made by Pam Ehrenberg and seconded by Gary Braun to approve the minutes as read. Motion passed.

The clerk and treasurer's financial report was read by the clerk. Bruce Johnson made a motion to accept the report as presented. Motion was seconded by Pam Ehrenberg. Upon vote motion passed.

Chairman Mike Berscheid presented the road report. Comments from residents included better gravel on Duckweed Drive and request to improve Downy Drive. Downy Dr. is a private road therefore it is up to the residents to improve the road. The Pillsbury Bridge replacement has been rescheduled for 2016 and the county will have a public hearing to give out details this summer. Gary Opatz made a motion to accept the road report and Gary Braun seconded the motion. Motion passed.

In old business the recycling bins and clean-up day were again discussed. Residents again would like to see the recycling bins clearly labeled with a list of what should be recycled. Clean-up day went well last year and the city helped pay for the expense with many Burtrum city residents using the service as well. This year's clean-up day is scheduled for Saturday, May 21. Residents present requested the times be adjusted with 9:30 to noon being suggested.

For new business crisis center donation was turned down, up-coming nitrate testing for the county was discussed, tree trimming on Dunlin Road was also covered. Todd County Sentence to Serve group will do tree trimming now, but township is responsible for spraying to control regrowth. Election results were announced with Bruce Johnson and Shirley Hulinsky being reelected with each getting 20 votes for their respective offices.

The budget was discussed next. Bruce Johnson made a motion to set the levies the same as last year at \$20,000 for Revenue, \$114,000 for Road and Bridge, and \$28,000 for Fire Fund. Motion was seconded by Gary Opatz. Upon vote motion passed.

Next year's election voting hours will again be from 5 until 8 pm and annual meeting will be held at 8:20 pm on a motion by Gary Allen and a second from Mike Berscheid. Motion passed with all voting in favor.

Pam Ehrenberg made a motion to adjourn and Louis Thompson seconded that motion. Meeting adjourned at 9:25 p.m. Shirley Hulinsky, Burnhamville Township Clerk
