March 13, 2018

The annual meeting of the residents of Burnhamville Township was held at the Burtrum Community Center on Tuesday, March 13, 2018. The meeting was called to order at 8:20 by the clerk Shirley Hulinsky. The Pledge of Allegiance was recited. Bruce Johnson made a motion to appoint Don Brown as moderator. Don Brown nominated Gary Opatz. Shirley Hulinsky seconded the motion to appoint Don Brown as moderator and upon vote motion passed.

The minutes of the annual meeting held on March 14, 2017 were read by the clerk Shirley Hulinsky. Motion was made by Gary Opatz and seconded by Bruce Johnson to approve the minutes as read. Motion passed.

The clerk and treasurer's financial report was read by the clerk. Gary Opatz made a motion to accept the report as presented. Motion was seconded by Don Brown. Upon vote motion passed. Residents discussed Swanville Rural Fire Association new truck purchase. Truck is ordered and old truck may be remodeled to use as possible extra water truck. Swanville and Grey Eagle fire departments are testing the dry hydrant that was put in the lake.

Clerk presented the road report. There was discussion on continuing brush cutting in the ditches to keep ahead of the growth that limits view of traffic. Residents thought it is cost effective to do the trimming while growth is small. Board member discussed doing more gravel on roads to build up base in several areas.

In old business the clean-up day and Forest Lane were discussed. Clean-up day went well last year. This year's clean-up day is scheduled for Saturday, May 19 and plan to have it the same time 9-11 am. Last year the residents of Forest Lane petitioned to have the township take over maintenance of that road. After the residents improved the road and public hearing was held, the township did take over maintenance in November.

For new business election results were announced with Joe Muellner being elected supervisor and Shirley Hulinsky being reelected clerk with each getting 14 votes for their respective offices.

The budget was discussed next. After discussion Bruce Johnson made a motion to keep the levy for the fire fund at \$33,000 in anticipation of the Swanville Rural Fire Association new truck payments and to keep the other levies the same as last year at \$20,000 for Revenue, \$114,000 for Road and Bridge. Motion was seconded by Gary Opatz. Upon vote motion passed.

Next year's election voting hours will again be from 5 until 8 pm and annual meeting will be held at 8:20 pm on a motion by Gary Opatz and a second from Bruce Johnson. Motion passed with all voting in favor.
