Burnhamville Township Annual Meeting

March 14, 2017

The annual meeting of the residents of Burnhamville Township was held at the Burtrum Community Center on Tuesday, March 14, 2017. The meeting was called to order at 8:21 by the clerk Shirley Hulinsky. The Pledge of Allegiance was recited. Terri Holmgren made a motion to appoint Don Brown as moderator. Bonnie Alsleben seconded the motion and upon vote motion passed.

The minutes of the annual meeting held on March 8, 2016 were read by the clerk Shirley Hulinsky. Motion was made by Terri Holmgren and seconded by Bonnie Alsleben to approve the minutes as read. Motion passed.

The clerk and treasurer's financial report was read by the clerk. Bruce Johnson made a motion to accept the report as presented. Motion was seconded by Mike Berscheit. Upon vote motion passed.

Chairman Mike Berscheit presented the road report.

In old business the clean-up day was discussed. Clean-up day went well last year and although the time was changed many people came earlier and the board thought that two hours was long enough. This year's clean-up day is scheduled for Saturday, May 20.

For new business. Election results were announced with Mike Berscheit and Pam Throener being reelected with each getting 21 votes for their respective offices. Forest Lane improvements and possible taking over of maintenance by the township was discussed. The Swanville Lions made a donation to the Swanville Rural Fire Association of \$90,000 over three years to purchase a new truck.

The budget was discussed next. After discussion Bruce Johnson made a motion to set the levy for the fire fund at \$33,000 in anticipation of the Swanville Rural Fire Association purchasing a new truck. Mike Berscheit seconded the motion. Upon vote motion passed. Terri Holmgren made a motion to keep the other levies the same as last year at \$20,000 for Revenue, \$114,000 for Road and Bridge. Motion was seconded by Bruce Johnson. Upon vote motion passed.

Next year's election voting hours will again be from 5 until 8 pm and annual meeting will be held at 8:20 pm on a motion by Shirley Hulinsky and a second from Don Brown. Motion passed with all voting in favor.

Bruce Johnson made a motion to adjourn and Mike Berscheit seconded that motion.
