Burnhamville Township Annual Meeting

March 9, 2021

The annual meeting of the residents of Burnhamville Township was held at the Burtrum Community Center on Tuesday, March 9, 2021. The meeting was called to order at 8:25 by the clerk Shirley Hulinsky. The Pledge of Allegiance was recited. Bruce Johnson nominated Don Brown as moderator. Joe Muellner seconded the motion to appoint Don as moderator and upon vote motion passed. Don suggested everyone introduce themselves.

The minutes of the annual meeting held on March 10, 2020 were read by the clerk Shirley Hulinsky. Motion was made by Gene Fischer and seconded by Mike Berscheit to approve the minutes as read. Motion passed.

The clerk and treasurer's financial report was read by the clerk. Bruce Johnson made a motion to accept the report as presented. Motion was seconded by Joe Muellner. Upon vote motion passed.

Chair Mike Berscheit presented the road report. Jan Lind motioned to approve the report and Gene Fischer seconded the motion. Upon vote motion passed.

In old business recycling every-other Saturday are well used.

For new business the annual clean-up day will be held May 22 from 9-11 am and the mayor suggested it be held in streets in town to help with traffic flow. Again there will be fees for a few items, but most junk will be free. Election results were announced with Joe Muellner and Pam Throener being reelected for their respective offices. Bruce Johnson suggested that the cartway from 321^{st} Ave and Flower Trail needs more gravel. It is fit for off road vehicles but trucks may damage it. One land owner asked about the speed limit on Flicker Road. It is set at 30 MPH but several people drive way to fast. The board will ask the Sheriff's department to patrol it more. They also had question about shoreline set backs. Todd County controls the planning and zoning in this township.

The budget was discussed next. With the road and bridge levy being increased last year discussion suggested leave the levies the same as last year. Bruce Johnson made a motion and Joe Muellner seconded it to have Revenue levy set at \$20,000, Road and Bridge levy set at \$140,000 and Fire levy set at \$33,000. Upon vote motion passed.

Next year's election voting hours will again be from 5 until 8 pm on a motion by Shirley Hulinsky and a second from Mike Berscheit. The annual meeting will be held at 8:20 pm following the election stated in a motion from Mike Berscheit and a second from Rita Reverman-Fischer. Motions passed with all voting in favor.

Mike Berscheit made a motion to adjourn and Joe Muellner seconded that motion. Meeting adjourned at 9:13 p.m.
