

PAVING OF TODD COUNTY ROAD 81 IN CALENDAR YEAR 2026

WHEREAS, the proposal of paving of Todd County Road #81 has been studied since the 1990s, and;

WHEREAS, Todd County Road #81 has been widened and graveled in preparation for paving in the 2000s, and;

WHEREAS, Todd County Road #81 is a vital roadway for Todd County's residents, and;

WHEREAS, the residents have filed a Todd County Road Paving Request Petition to upgrade the existing aggregate surface of County Road #81 to a paved asphalt surface, and;


WHEREAS, the Todd County Board of Commissioners implemented the 0.5% Transportation Sales and Use Tax to fund county road projects for the betterment of Todd County's citizens.

NOW, THEREFORE BE IT RESOLVED, that the Todd County Board of Commissioners hereby order that the paving of Todd County Road #81 be prioritized and scheduled to construct in the Calendar Year 2026 with funding supported by but not limited to the Transportation Sales and Use Tax.








Creating the following spreadsheet/process to help develop an invest strategy for Enhancement Projects located on the County Road System. The Process will use the following road attributes to assign project rank.

Road Attributes	Description	Weighted Average
Project Terminii	The importance of where the road starts and stops.	10%
Traffic Volume (ADT)	The average amount of daily traffic the road experiences.	50%
Entrance	The number of entrances/homes that are on the road.	20%
Governing Body	The importance of the road to the District as determined by the County Commissioner.	10%
Public Input	The importance of the road to the area as determined by the Residents.	10%



Project Termini Attribute – The amount of "points" the County Road receives is dependent on the level of the road that the County Road intersects with at is termini (start and stop location).

Township Road Termini = 0 Point

County Road Termini = 1 Point

County State Aid Highway Termini = 2 Points

State Highway Termini = 3 Points

The amount of "points" is then divided by 4 to create a factor that is then comparable to the other attributes.

Project Termini Attribute provides 10% of the Overall Segment Ranking



Project ADT Attribute – The amount of "points" the County Road receives is dependent on the ADT (Average Daily Traffic). This number is typically derived from the MnDOT Traffic Volume and Forecasting Website.

The amount of "points" is then divided by 100 to create a factor that is then comparable to the other attributes.

Project ADT Attribute provides 50% of the Overall Segment Ranking



Project Entrance Attribute – The amount of "points" the County Road receives is dependent on the number of Entrances that access the road. This number was provided by the GIS Department based on the number of E-911 addresses assigned to the road.

The amount of "points" is then divided by the segment length (in miles) to create a factor that is then comparable to the other attributes.

Project Entrance Attribute provides 20% of the Overall Segment Ranking



Governing Body Attribute – The amount of "points" the County Road receives is dependent on the recommendation of the County Commissioner in the District. Each Commissioner is suggested to submit a recommendation letter (see example below) for their recommended project.

The County Road receives one point for each recommendation letter.

Governing Body Attribute provides 10% of the Overall Segment Ranking





Option 1 – Use Local Option Sales Tax



Option 2 – Use Cash from Road and Bridge Account (Fund 3)


This would decrease the balance to an amount below the recommended 5 months of reserves.





Option 3 - Use Cash from County's General Fund


This account has adequate funds above the recommended 5 month reserve threshold.

Option 5 – Use Combination of Various Funding Sources

General Fund Cash Reserves (50% of Cost) = \$600,000

Local Options Sales Tax (25% of Cost) = \$300,000

Road & Bridge Fund Cash Reserves (25% of Cost) = \$300,000

Total Revenue = \$1,200,000



Additional Financing Options for Paving CR 81

#1 Approval of One Time Local Levy Budget Increase in FY 2027 of \$200,000

This will dedicate an annual deposit of \$200,000 into a dedicated County Road 81 construction account which will pay for the project in 6 - 7 years.

#2 Approval of Dedicating County Debt Payment in FY 2028 to Road & Bridge

This will dedicate an annual deposit of \$365,700 into a dedicate County Road 81 construction account which will pay for the project in 3.5 - 4 years.

#3 Approval of a Bond & Payoff Bond with A Levy Increase or Other Debt Payments

Borrow $\frac{$1,200,000}{}$ and construct the project in FY 2026 and pay back in $\frac{4-6}{}$ years.

#4 Approval of Assessment Project

Borrow \$1,200,000 and construct in FY 2026 and assess property owners over 20 years.

Note: this would cost each adjacent parcel around \$2,800/year
